


Structure of the board/ club

MOTIONS by EC



#1 Motion proposition CLARIFY

Article 21

Le conseil d'administration devra comprendre au moins trois membres.

L'assemblée générale nomme le président et les quatre ou six membres permanents du Conseil,

Le conseil d'administration est responsable de toutes les tâches liées à la gestion de l'association, sauf mention contraire dans la loi ou les présents statuts. Le conseil d'administration représente solidairement l'association dans toutes les situations.

Le conseil d'administration peut décider qu'un ou plusieurs membres du conseil d'administration, agissant personnellement ou solidairement, soient habilités à agir au nom de l'organisation. Une telle décision peut être révoquée à tout moment.

Article 22

Le président est élu pour un an. Les autres membres du conseil d'administration sont élus pour deux ans avec chevauchement des mandats. Le conseil d'administration assigne parmi ses membres un vice-président, un trésorier, un secrétaire et d'autres fonctions qu'il considère nécessaires.

Article 23

En cas de poste vacant pendant une période de mandat le Conseil peut convoquer une assemblée extraordinaire afin d'élire un remplacant.

Dans le cas où le président est dans l'incapacité de remplir ses devoirs, ses fonctions sont assumées, en premier lieu par le vice-président et, en second lieu, par le membre du Conseil ayant la plus grande ancienneté dans ses fonctions.

Article 24

Le conseil d'administration est convoqué par le président chaque fois que les intérêts de l'association l'exigent, et au moins six fois par an. Une réunion du conseil d'administration peut également être convoquée à la demande d'au moins la moitié de ses membres. Le conseil d'administration ne peut agir qu'en présence d'une majorité de ses membres.

Le conseil d'administration décide par le vote à la majorité. En cas d'égalité des voix, le président ou le membre du conseil d'administration le remplacant dispose d'une voix prépondérante. Les réunions du conseil

#2 Motion proposition

2019 proposal

13 Proposals from the Board and in time submitted motions (proposals submitted by members).

Annika Liljeberg-Hallonsten submitted a motion to limit the number of years any one person can serve on the Board. She proposes the limit to be six years.

Reply of the Board emphasizes the lack of candidates for Board position and continuity is important. It proposes that the Assembly vote for the following: to give consent for a time limit of 6 years, to agree that the Board member commits to a minimum of two years, to grant the Election Committee the right to extend for one year maximum if a replacement candidate can not be found.

Vote: 26 Yes for motion in totality of three suggestions from Board 14 No against motion in totality.

Comments from the Assembly

Przemek Sowinski asked where does 5 years comes from.

Annika Liljeberg-Hallonsten answered that is it the maximum term for most in Swedish clubs.

Lene Kristensen notes that the mandate is 2 year but the minimum is one year. She asked is this to change. Calle Asenius asked statute or procedure?

Annika replied it should be in the Rules of Procedure for the EC since a chage in statutes is very cumbersome.

Taria Kallio asks if someone does six years, can they come back at a later date?

Alex Mascia states that it is six years max.

Nolwenn Couzigou asks what happens after extra year.

Karlheinz Kadner asks if we needed to have this type of proposal. Suggested that we go for trust and confidence in the Election Committee (EC)

Jeroen Overstijn thinks it is just a formality and that there is no added value.

Nolwenn Cozigou stated that the implication is to push people from the Board

Calle believes it is to help get people on the Board but agrees with Karlheinz that it should be left to the EC.

Vera Fehnle states that this rule could help the EC if you wanted to help the EC.

Olivier Baeten believes it is a good rule can help the EC

Przemek Sowinski states that power corrupts as he has noted in his work environment. Time limit would help prevent individuals from building empires.

#3 Call for replacement

Rules of Procedure and Guidelines for the Election Committee of Friskis&Svettis Brussels / guidelines EC- 2022

The responsibilities of the Election Committee (called hereafter "EC"), are defined in article 18 of the Statues of Friskis & Svettis Brussels absl/ VZW (called hereafter "the club")

The purpose of these Rules of procedures and Guidelines is to clarify the role of the election Committee and the basic requirements of the members of the election Committee.

Article 1: Composition of the Election Committee

The persons in the EC

- are nominated every year (either by former members of the election Committee of self proposed during the AGM)
- shall be composed of members of the club
- have a good knowledge and experience from the club
- not a member of the board
- is composed of a president and 2 members

In order to have both continuity and renewal, at least one member of the EC should be replaced every year. No member should serve longer than 5 years. Deviations from this should be motivated to the AGM.

In the event that a member of the EC is being proposed for members of the board, he or she must immediately withdraw from the EC.

No by election is needed if a member leaves his or her post before the expiration of the mandate.

Article 2: Mission of the EC

The EC receives its mandate from the AGM and reports to the AGM. Its mission is to purpose the best possible board for the club composed of a chairperson and other members of the board, that will work as a team to meet the aims and objectives of the organization.

The proposal from the EC should ensure that the board to be selected can manage both current administration and engage towards in forward looking work.

In addition to the requirements defined in the statutes of the club, article 18, the EC should look for the following qualities in potential candidates for members of the board

- -relevant knowledge and experience
- -readiness to serve the full mandate they would be elected for
- -reflect the composition of the association in terms of age gender and cultural background.
- -Not mandatory but a plus that at least one member of the board, speaks and/or understand Swedish.

The EC shall propose if and by how much the board should be remunerated.

The EC does not play a role of internal audit of the work of the board.

In case of disagreement within the EC one member of the EC can ask that the divergence of opinion be shared during the AGM.

Article 3: Work of the EC

The EC should remain accessible via the website and email (email created elec.fbrussels@gmail.com)

The EC shall identify the needs and challenges from the club. After collection of necessary information, it shall propose a Board to meet those criteria. The EC shall consult widely amongst volunteers and members.

The EC should, a few months before the foreseen AGM, ask existing board members if they wish to be considered for re-election for a further period.

In addition, any other member who wishes to be considered for election to the board, or wishes to purpose someone, should inform the EC in writing (email) at least one month prior the the foreseen AGM.

The list proposed should also include the persons that have been nominated but not proposed by the EC.

These rules of procedures and guidelines were first adopted by an extraordinary AGM in 2014 and shall be revised whenever is necessary. This version has been amended by the EC in May 2021, and proposed to the AGM in June 2021.
